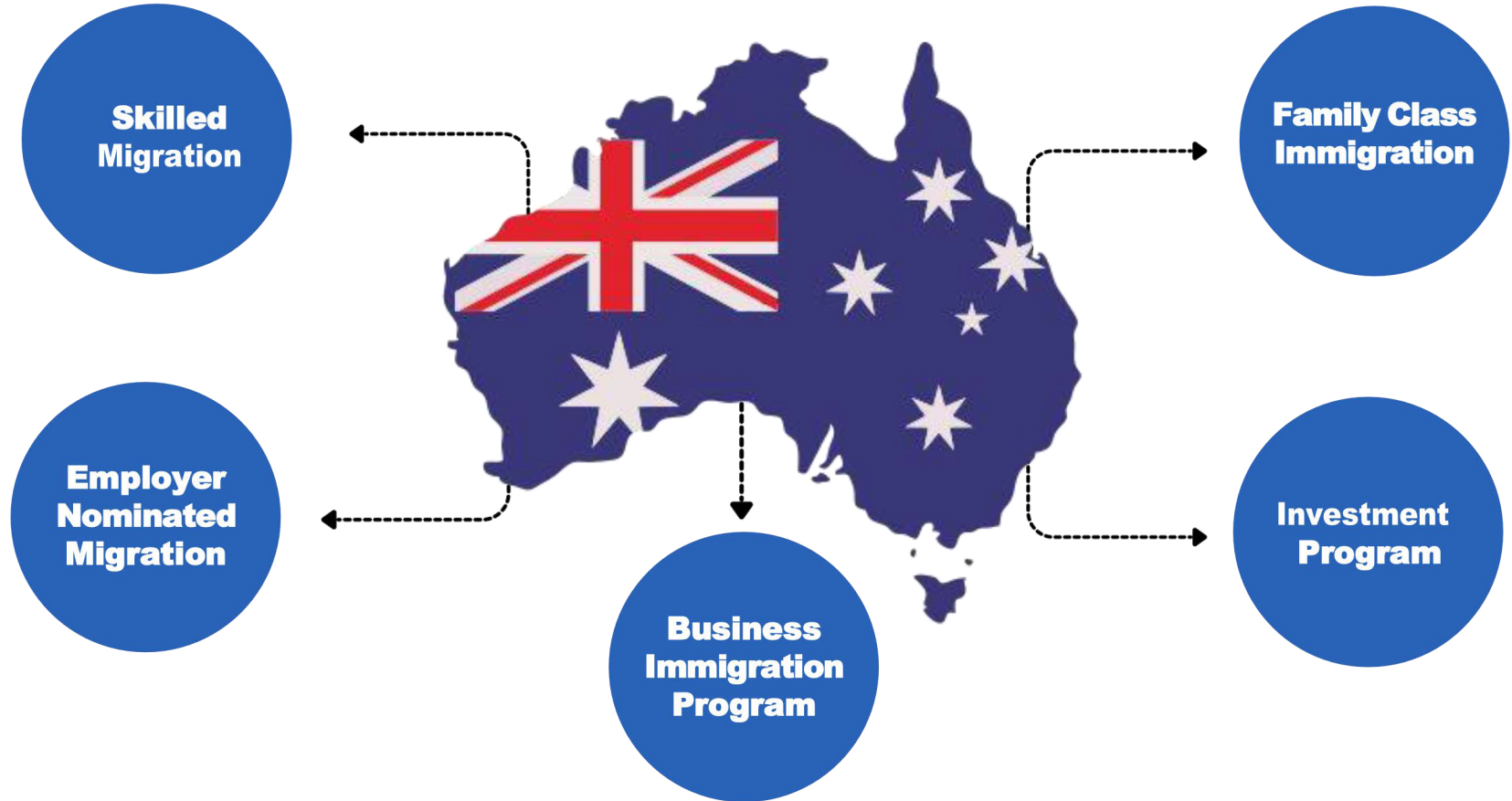

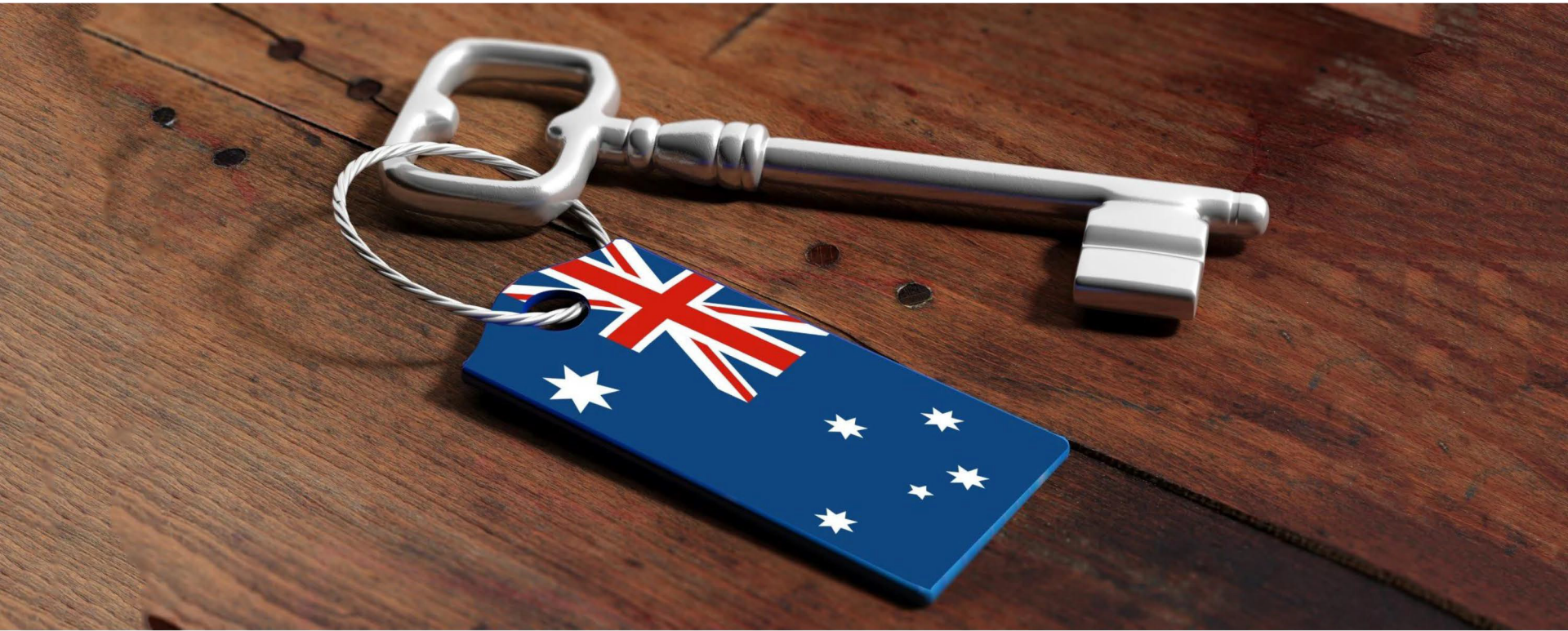

Step 1 = Skill Assessment

Skill assessment is based on the following factors:

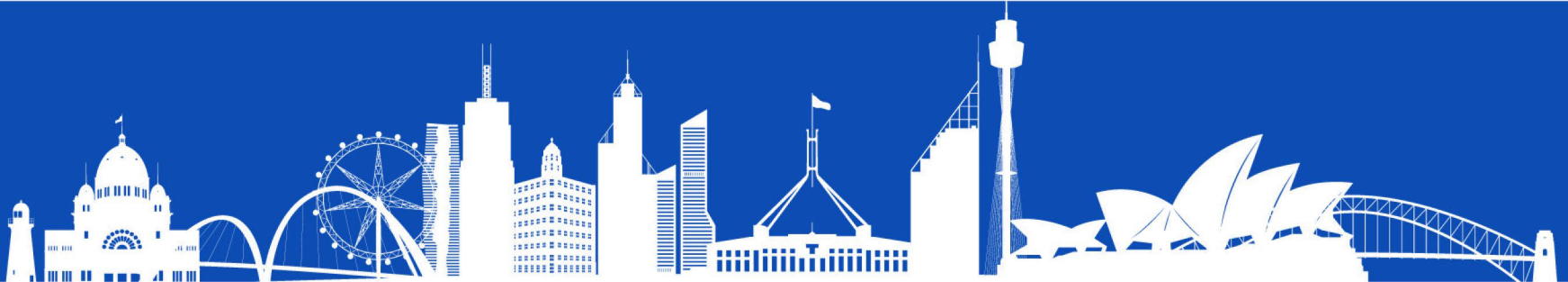

STEP 2 = EOI (Expression of Interest) / ROI (Registration of Interest)

1. Once your Skill Assessment and Language Test (IELTS/PTE) are completed, we submit your EOI / ROI.
2. Upgrade complete the application at the earliest Upon receiving your:
 - a. Skill Assessment Result.
 - b. IELTS/PTE Band.



STEP 3 = ITA (Invitation to Apply)

- ITA is issued by **AUSTRALIAN AUTHORITIES.**
- Increase your chance of getting PR.
- An applicant with ITA needs to fill Visa Grant Letter.



Australia Permanent Resident Visa grants non-Australian citizens the right to live, work, and study in Australia indefinitely, with access to social benefits and protection under Australian law. It is a step toward gaining full Australian citizenship.

Applying to Australia can be through Skilled Migrant Visa Nomination depending on the occupation demand list.

Australia via Skilled Migrant:

Candidates applying for the Australia PR visa through the skilled Migrant Program must use a points-based selection system. The Skilled Migrant basically consists of three sub-categories.

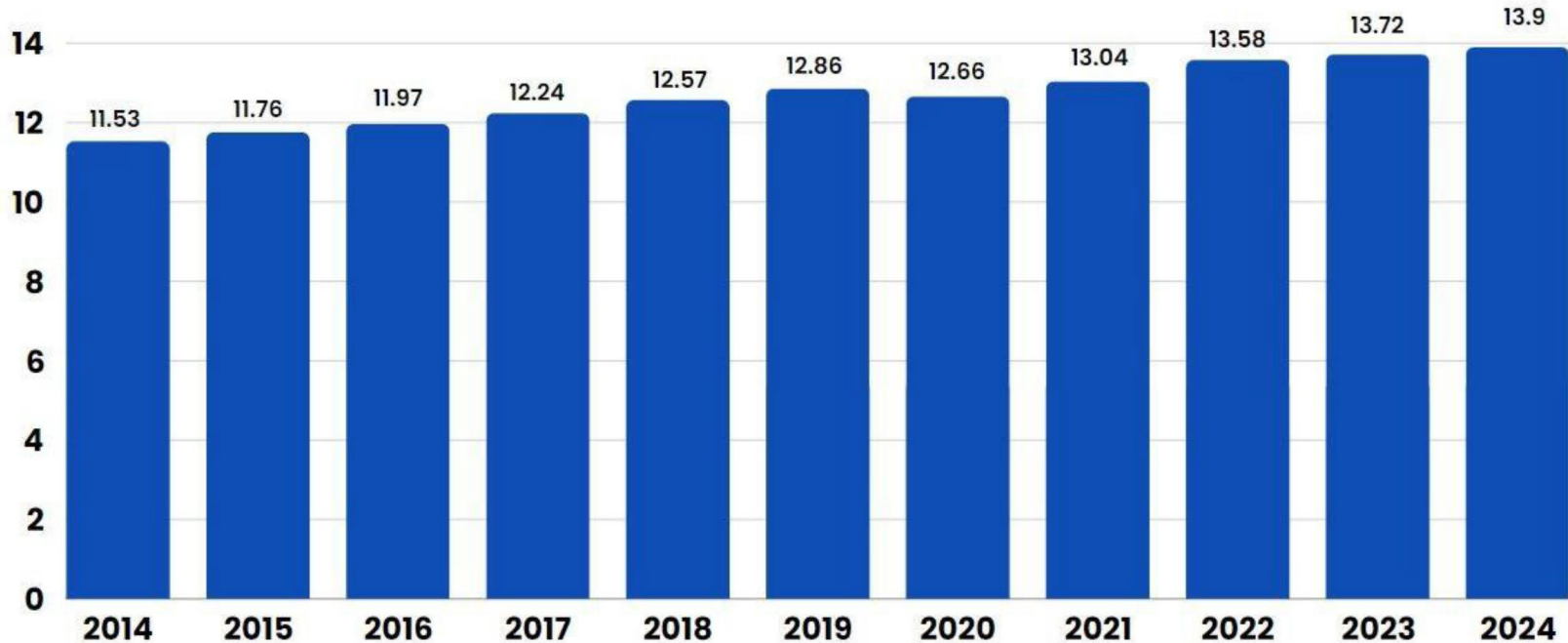
Phase wise process & cost.

Australian Skill Assessment AUD \$500 – AUD \$ 4,300 (Depend upon assessment body)	Once ITA is received, Prepare documents for Police and Medical Clearance.
English language Test You can choose between IELTS, CAE & PTE. Getting a proficient language score in each Parameter in the language exam is a must. (Depends upon the assessment body)	Biometrics and Visa Stamping.
Upon receiving a positive Skill Assessment, we submit your online “Expression of Interest” (EOI) in the Skill Select to the (D.H.A.).	Once a Visa is received, it is best suggested to enter the country as soon as possible to activate the Permanent Residency card at the Port of Entry.
State Sponsor (*if applicable) AUD \$200 – AUD \$ 450 – depending on sponsoring state AUSTRALIA	Upgrade Service Fee: (RMA Sign-Up): 3,30,000 + Tax (18%)
