Canada Permanent Resident Visa is a gateway to permanent resident status in Canada. A Canada Permanent Resident Visa grants non-Canadian citizens the right to live, work, and study in Canada indefinitely, with access to social benefits and protection under Canadian law. It is a step toward gaining full Canadian citizenship.

Applying to Canada can be through Express Entry and Provincial Nomination depending on your occupation.

Canada PR via Express Entry:

Candidates applying for the Canada PR visa through the Express Entry program must use a points-based selection system. The Express Entry System basically consists of three sub-categories:

- 1. Federal Skilled Workers Program (FSWP)**
- 2. Federal Skilled Trades Program (FSTP)**
- 3. Canadian Experience Class (CEC)**

Canada PR via PNP

Canada offers multiple Provincial Nominee Programs which have their individual eligibility requirements. The PNP program allows provinces to meet their individual immigration needs by helping them fill jobs that are in demand and meet labour shortages in their province.

Predominant PNP programs for a Canada PR visa are:

Step by Step Procedure for the application of the Visa:

Step 1: Payment of Udaan Service Fee to process the application. Registration and Report will be shared to give clearance.

Step 2: Designated Process Consultant will be assigned and a Check list of documents required will be provided. Gather all the required documents.

Ensure you provide only genuine documents. Remember that the education and work experience documents require authentication

Step 3: Educational Credential Assessment will be assessed by WES (World Educational Services) . Government Fee to the authority approximately CAD 305.

Step 4: Language Assessment Test . You can choose to take IELTS, PTE or CELPIP of you preference (Approximately Inr 17,000)

Step 5: Documentation collation and profile launch . Profile will be created in Express Entry and also respective PNP programs applicable to the applicant will be applied for.

Step 6: Waiting time

Step 7: Once ITA is received, Prepare documents for Police and Medical Clearance.

Step 8: BioMetrics and Visa Stamping. Visa Fee: 950 CAD and Right to Resident Fee: 575 CAD

Once a Visa is received, it is best suggested to enter the country as soon as possible to activate the Permanent Residency card at the Port of Entry.

Upgrade Service Fee: (RCIC Sign-Up): 3,30,000 + Tax (18%)
