Eligibility

The candidate should have good communication skills. English should be fluent. The candidate should demonstrate comprehension in speaking, listening, reading & writing. The candidates must be pursuing Degree/ Diploma in Hotel / Hospitality Management. The candidate can be a fresher. The age limit is 25 years.

Interview Process

Upgrade offers internship program for both Hospitality and Hotel Industry. The main objective of this internship is to enhance the international skills and meet international hospitality standard. We register the candidate in the Europe program, followed by documentations. Once the applicant is ready with the documents we allow them to attend the 1st round of the interview (Sponsor Interview) via Skype or Zoom. The second step is to attend the host company interview and once the applicant is selected, the sponsor will offer the appointment letter.

Visa Process

Upgrade assists in the France VISA processing along with documentation. The final step is to attend the Visa interview at French Embassy; we would assist in preparations of visa interview. The applicant attends the French Embassy interview to participate in the internship program.

Candidates will be sending all original documents for visa purpose, not to put any fake documents for securing the visa. After getting visa Upgrade will take care of all necessary things in France like all post landing services such as receiving clients and take them to company and other offices if required for any.

Documents Checklist

- Original Passport (not less than 6 months).
- Resume.
- Documents of 10th, 12th and College.
- College NOC.
- College ID (photo copy both side).
- 4 copy photo (80% face cut/white background with formal attire).
- CDS (upon receipt).
- Accommodation letter (upon receipt).
- Sponsorship letter (Notarized).
- Covering letter.
- Financial documents as per KYC.
- Bank Statements (INR 4 lakhs).

NOTE: Any additional document may be required during VISA process according to the demand of the embassy.

COVID PROTOCOL :

- *All candidates must be having 2 doses of vaccination approved by WHO, passport and 1 minimum certificate of the doses.*

Terms & Conditions -

- Price may differ due to usd/eur conversions. (Calculations as per usd/eur conversions)
- Conversion into INR is subjected to currency market changes.
- All disputes are subjected to 'Kolkata Jurisdiction' only.
- The applicants are not supposed to pay the fees in any personal A/C or any sort of cash transaction.
- Flight Tickets are not included in the program fees. Tickets booked by students need to be reschedulable tickets.
- Candidates are not supposed to email sponsor or host companies directly.
- Candidates are requested to cooperate during the entire process time.
- The placements can be in any hotels or restaurants in France. No choice will be provided
- Candidates cannot back out after the property is allotted.
- In case of Visa rejection, the amount 800 Euros + tax is non-refundable.
- In case candidate backs out after receiving CDS registration fee 500 EUR + cds fee is non-refundable
- In case of non-selection after 3 interviews, the amount 300 Euros is non-refundable.
- In cases pertaining to no fault of students, are eligible for full refund as per company rule.
- Student will have Udaaan Edge to ensure 100% protection of their payment & non selected candidates can convert to any other country without any deduction.
- 100 EUR/ USD embassy courier documentation charge extra.
- Service charge and Taxes applicable.
- Indian VFS charges excluded.
- 95 EUR/USD avent fee charge extra.
- Program registration fee is not refundable after property allocation/ interview selection.
- Document evaluation fee is completely non-refundable.
- No refund will be initiated after VISA. If candidate fails to travel after receipt of visa, candidate cannot claim any refunds.
- All financial transaction will be done as per the current value of USD/ EUR (+ INR 2 on trading value).
- Taxes Extra and Bank Charges, remittance charges extra.
- Duty roster, weekly offs, OT, job role as per host property terms & conditions.
- Standard processing time of visa is minimum 90 working days from submission of signed offer letter, cds, college NOC, and other requisite documents (PLEASE NOTE SATURDAY, SUNDAY AND ANY PUBLIC HOLIDAY IS NOT COUNTED).
- General accommodation will be on sharing basis it is the students duty to keep the accommodation clean and in good condition.
- Pickup from airport/train/bus station on arrival can only be provided if tickets are shared for 72 hrs prior departure (no arrival on saturday and sunday until approve from UPGRADE).
- Student is responsible for all its belongings in case of theft only official complain can be entertain.
- In the event of student unable to adjust themselves in the property after arrival at France or asking to change the property UPGRADE will not be liable to change the property. Property can only be changed in case there is any availability and if changed there will be a separate placement fee of 650 EUR which to be paid by the student.
- Standard duty meals are to be provided by the property which shall consist non vegeterian food in case student is a vegeterian they shall require to manage their own meals or adjust with veg food served by the property. Student duty meals timings shall be as per standards property duty meal timings and not as per student personal choice.
- Any student receiving more than 3 warnings may subjected to termination.
- Student have to accept and adjust French culture, food, climate and learn from the same.
- Property change only incase of extreme conditions (justified by the property with sufficient legal proof) with sole discretion of agency, prior written approval.
- Host company reserves right to give overtime or comp off as per company's terms & conditions.
- It is mandatory for a student to validate their visas once they reach France following the to do list
- Candidates must be prepared to work in straight shifts/ break shifts as per company policy
